- 1.0 Eligibility criteria:- The tenderer shaold fulfil the eligibility criteria mentioned below:-
  - (i) Tenderer should have completed at least one similar single work, i.e. "i.e. Construction / Maintenance to Road works for a minimum value of 35% of the advertised tender value of work in the last three financial years i.e. (current year and previous three financial years).
  - a) Similar nature of work physically completed within the qualified period i.e. the last three financial years and current financial year will only be considered in evaluating the eligibility criteria.
  - b) The total value of similar nature of works completed during the qualifying period and not the payment received within the qualifying period alone will be considered.
  - c)Certificates from private individual/private limited company/Public Limited Company (Private Sector) for whom such works are executed shall not be accepted. Certificates from Govt./Semi Govt./PSU/Govt. Autonomous Bodies/Public Limited Company (Govt. Sector) of India will only be accepted.
  - (ii) Total contract amount received by the tenderer during the last three financial years and in the current financial year should be a minimum 150% of the advertised tender value. Tender Committee will satisfy themselves about the authenticity of the certificates produced by the tenderer to this effect which may be an attested certificate from the employer/client, audited balance sheet duly certified by the Chartered Accountant etc.
  - (iii) Tenderer must enclose relevant certificates in support of the above eligibility criteria in absence of which, their tender may be liable to be rejected.
  - 2. Tender document in person or through their authorised representative may be obtained from the office of the Chief Engineer, KMRCL on any working day during 11.00 hrs. to 18.00 hrs. from 26.02.2016 to 21.03.2016 on payment of Rs.10,000/- (Rupees Ten Thousand only) non-refundable for cost of tender document in the form of a Demand Draft issued by a Scheduled Commercial Bank in favour of "Kolkata Metro Rail Corporation Limited" payable at Kolkata.
  - 3. (a)The Tender document can also be downloaded from web site <a href="www.kmrc.in">www.kmrc.in</a> The cost of tender form has also to be paid in the shape of demand draft issued by a Schedule Commercial Bank in favour of "Kolkata Metro Rail Corporation Limited" payable at Kolkata.
  - (b) Tenderers are requested to visit the work site before quoting the rate.

- 4. The tender must be accompanied by Earnest Money of Rs. 4,00,000/- (Rupees Four Lakhs only) in the form of a Demand Draft issued by a Scheduled Commercial Bank in favour of "Kolkata Metro Rail Corporation Limited" payable at Kolkata. Tender received without prescribed Earnest Money will be liable to be summarily rejected.
- 5. (a) No previous earnest money or security deposit etc. submitted earlier in connection with any tenders floated by KMRCL what-so-ever will be adjusted towards the present tender nor any such request or correspondence will be entertained.
- (b) The tenderer shall keep the offer open for a period of 120 daysfrom the date fixed for opening the tender. It is being understood that the tender documents have been sold/issued to tenderers and the tenderer is being permitted to tender in consideration of the stipulation on his part that after submitting his tender he will not be resile from his offer or modify the terms and condition s thereof in a manner not acceptable to the KMRCL. Should the tenderer fail to observe or comply with the forgoing stipulation the full amount of Rs.4, 00,000/- shall be forfeited to the KMRCL.
- (c) Tender received with less than 120 days validity time is liable to be rejected.
- 6. Tender complete with all documents are to be submitted in a sealed envelope super scribing the name of work and should be deposited in the office of Chief Engineer, KMRCLs on 22.03.2016 up to 14.00 hrs. Tender duly sealed and superscribed as above may also be sent through registered post so as to reach the Chief Engineer, Kolkata Metro Rail Corporation Limited, KMRCL Bhawan (2<sup>nd</sup> Floor), Munshi Prem chand Sarani, Kolkata 700021 not later than 14.00 Hrs. on 22.03.2016. However KMRCL will not be responsible for any delay in receipt of Tender Documents through post. The tender shall be opened on 22.03.2016 at 16.30 hrs. at KMRCL Conference Hall, KMRCL Bhawan (2<sup>nd</sup> Floor), Munshi Prem chand Sarani, Kolkata 700021 in presence of authorized representative of the tenderers. Any delayed /Late Tender received after 14.00 hrs. shall be rejected at the sole discretion of the KMRCL.
- 7. No tender document will be sent through post.
- 8. The tender document is not transferable.
- 9. Participation of Joint Venture (JV) firm is not permitted in this tender.
- 10. Price variation clause shall be applicable only for contracts of value (Contract agreement value) Rs.50 Lakhs and more.
- 11. In case date of opening of tender as mentioned above is declared to be holidays, the tenders shall be received and opened, on the next working day at the same time and venue.
- 12. KMRCL reserves its right to either cancel the tender or rejects any or all the tenders without assigning any reason thereof.
