01.	Name of the work	: Architectural finishing works and plumbing works for Six elevated stations and RCC structural roof over platform of Sector-V Station of East West Metro Project.

06.	Eligibility Criteria	: (i) Experience of having successfully completed similar works during last 7(seven) years ending 31.05.2015: a. One similar completed works costing not less than amount equal to 80% of estimated amount put to tender. or b. Two similar completed works costing not less than amount equal to 50% of estimated amount put to tender. or c. Three similar completed works costing not less than amount equal to 40% of estimated amount put to tender. Similar works means architectural finishing for Metro Stations, Railway Stations, Airports, Conventional Centres or other important commercial /residential building including concreting items.

		<p>(ii) Average annual financial turnover during the last 3(three) years ending 31st March, 2015 should be at least 30% of estimated amount put to tender.</p> <p>(iii) the net worth of the Tenderer should be positive for last 3(three) years viz. 2012-13, 2013-14, 2014-15. In case of group (Joint venture/Consortium) profitability, for each member whose financial participation is >10% will be evaluated. Each member of the joint venture is required to demonstrate positive net worth.</p> <p>(iv) The prospective applicant will have to give an affidavit that the applicant has neither have abandoned any work nor any of their contract have been rescinded during last three years. Such abandon and rescission will be considered as disqualification towards eligibility.</p> <p>(v) All materials are to be procured and supplied at site of work by the tenderer/firm at his/their own cost from approved/reputed firm/dealer/manufacture.</p> <p>(vi) The tenderer shall have to mobilize all men, machinery and field-testing machinery equipped with apparatus and instruments within 7 days from the date of Work Order.</p> <p>(vii) The offer shall remain valid for 150 days from the date of opening of the Tender.</p> <p>(vii) Conditional tender will not be acceptable.</p> <p>(viii) The contractor/agency will have to produce valid latest IT Return, PAN, VAT, Professional Tax certificate with the application along with other copies of relevant documents [copies to be attached with application and original to be produced for verification] not limited to:</p> <ul style="list-style-type: none"> (i) Attested copy of Power of Attorney (in favour of Authorised Signatory of Tenderer.
